1 Plaintiff and Defendant Younomics Private Student Loan Trust, by and through
2 their undersigned attorneys, hereby stipulate to the entry of a judgment in the form
3 submitted herewith for the reasons set forth below.

4 Plaintiff and Defendant Younomics Private Student Loan Trust participated in
5 and completed a settlement conference with The Honorable Peter C. McKittrick on
6 March 16, 2015. During this settlement conference the parties agreed to the dismissal of
7 Plaintiff's claim for discharge of her liability on various student loans based on hardship
8 and further agreed to stipulate to judgment of non-dischargeability of her student loan
9 obligations to Defendant Younomics Private Student Loan Trust under 11 U.S.C. §
10 523(a)(8) in the principal amount of \$5,434.78 as of May 10, 2012, together with accrued
11 interest thereon through said date, in the sum of \$10,779.69, with interest continuing to
12 accrue thereafter at the rate of 7.0125% per annum on the principal amount from May
13 11, 2012 until paid.
